#### OFFICE ORDER

By virtue of powers vested in it under Service Bye-laws and Clause 17 (i) of Article 133 of the Memorandum and Articles of Association of H.P. State Civil Supplies Corporation Limited, the Board of Directors of the Corporation in its 170<sup>th</sup> meeting held on 14.07.2022 vide Agenda Item No. 170.11 after recommendations of the Service Committee has approved the conversion of 65 posts of Clerk into the cadre of Junior Office Assistant (Accounts) by abolishing 65 posts in the cadre of Clerk alongwith the Recruitment & Promotion Rules for the post the amendments in Recruitment & Promotion Rules for the post of Clerk.

Accordingly, the cadre of Clerk shall consist of 73 posts in H.P. State Civil Supplies Corporation Limited in the pre-revised Pay Band of Rs. 5910-20200+1900 Grade Pay/revised scale & Level-3 of the Pay Matrix [₹20,200-64,000] as per HPCS (RP) Rules, 2022. Consequent upon the amendments, the Recruitment & Promotion Rules for the post of the post of Clerk shall be as under: -

		(I) CONCEPT Under this policy, the Clerk in the H.P. State Civil Supplies Corporation Limited will be engaged on contract basis initially for one year which may be extendable from year to year basis.  Provided that for extension/renewal of contract period on year to year basis, controlling officer shall issue a certificate that the service and conduct of the contract appointee is satisfactory during the year and only then his/ her period of contract is to be renewed/ extended.
		POST FALLS WITHIN THE PURVIEW OF HPSSC: -  The Managing Director after obtaining the approval of the Government to fill up the vacant post (s) on contract basis will place the requisition with the concerned recruiting agency i.e. Himachal Pradesh Staff Selection Commission, Hamirpur.  The selection will be made in accordance with the eligibility conditions prescribed in these R & P Rules.
		(II) CONTRACTUAL EMOLUMENTS: -

The Clerk appointed on contract basis will be paid consolidated fixed contractual amount ₹12,120/-P.M. (which shall be equal to 60% of the first cell of the applicable level of Pay Matrix of the corresponding cadre).

### (III) <u>APPOINTMENT/ DISCIPLINARY</u> AUTHORITY:-

The Managing Director, H.P. State Civil Supplies Corporation will be appointing and disciplinary authority.

#### (IV) SELECTION PROCESS: -

Selection for appointment to the post in the case of contract appointment recruitment shall be made on the basis of merit of written examination and/or practical test or skill test or physical test, the standard/syllabus etc. will be determined by the Himachal Pradesh Public Service Commission/H.P. Staff Selection Commission/other recruiting agency/authority, as the case may be.

# (V) COMMITTEE FOR SELECTION OF CONTRACTUAL APPOINTMENTS: -

As may be constituted by the concerned recruiting agency i.e. the H.P. Staff Selection Commission, Hamirpur from time to time.

## (VI) AGREEMENT: -

After selection of a candidate he/she shall sign an agreement as per **Annexure-B** appended to these rules.

## (VII) TERMS AND CONDITIONS: -

- a. The Clerk appointed on contract basis will be paid consolidated fixed contractual amount of ₹12,120/-P.M. (which shall be equal to 60% of the first cell of the applicable level of Pay Matrix of the corresponding cadre).
- b. The service of the contract Appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory. In case the contract appointee is not satisfied with the termination orders issued by the Appointing Authority, he/she may prefer an appeal before the Appellate Authority who shall be higher in rank to the Appointing Authority, within a period of 45 days from the date on which a copy of termination

orders is delivered to him/her.

c. The contract appointee will be entitled for one day's casual leave after putting one month's service, 10 days medical leave and 5 days special leave, in a calendar year. A female contract appointee with less than two surviving children may be granted maternity leave for 180 days. A female contract appointee shall also be entitled for maternity leave not exceeding 45 days (irrespective of the number of children) during the entire service, in case of miscarriage including abortion, on production of medical certificate issued by the authorized Govt. Medical Officer. A contract employee shall not be entitled for medical re-imbursement and LTC etc. No Leave of any other kind except above is admissible to the contract appointee.

Un-availed casual leave, medical leave and special leave can be accumulated upto the calendar year and will not be carried forward

for the next calendar year."

d. Unauthorized absence from the duty without the approval of the Controlling Officer shall automatically lead to the termination of the contract. However, in exceptional cases where the circumstances for un-authorized absence from duty were beyond his/her control on medical grounds, such period shall not be excluded while considering his/her case for regularization but the incumbent shall have to intimate the controlling authority in this regard well in time. However, the contract appointee shall not be entitled for contractual amount for the period of absence from duty.

Provided that he/she shall submit the certificate of illness/fitness issued by the Medical Officer, as per prevailing instructions

of the Government.

e. The contractual employee in the H.P. State Civil Supplies Corporation shall not be entitled for his/her transfer from one place to another during the first three years of his/her contractual appointment. Even on completion of three years tenure at one place of posting, he will be eligible for transfer on need based basis wherever required on administrative grounds.

Selected candidate will have to submit a certificate of his/her fitness issued by a Medical Board in the case of a Gazetted Government servant and by Government Medical Officer in the case of a Non-Gazetted In case of women Government servant. candidates who are to be appointed against

		posts carrying hazardous nature of duties, and in case they have to complete a period of training as a condition of service, such woman candidate, who as a result of tests is found to be pregnant of twelve weeks standing or more shall be declared temporarily unfit and her appointment shall be held in abeyance until the confinement is over. Such woman candidate be reexamined for medical fitness six weeks after the date of confinement, and if she is found fit on production of medical fitness certificate from the authority as specified above, she may be appointed to the post kept reserved for her.  g. The contract appointee will be entitled to TA/DA if required to go on tour in connection with his/her official duties at the same rate as applicable to regular counterpart official at the minimum of pay scale.  h. Provisions of service rules like FR, SR, Leave rules, GPF Rules, Pension Rules and Conduct Rules etc. as are applicable in case of regular employees will not be applicable in case of contract appointee. They will be entitled for emoluments etc. as detailed in this column.

Whereas the SECOND PARTY has engaged the aforesaid FIRST PARTY and the FIRST PARTY has agreed to serve as Clerk on contract basis on the following terms and conditions: -

2. The contractual amount of the FIRST PARTY will be 60% of the first cell of the applicable level of Pay Matrix of the corresponding cadre, as per H.P. Civil

Services (Revised Pay) Rules, 2022.

3. The service of the contract Appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory. In case the contract appointee is not satisfied with the termination orders issued by the Appointing Authority, he/she may prefer an appeal before the Appellate Authority who shall be higher in rank to the Appointing Authority, within a period of 45 days from the date on which a copy of termination orders is delivered to him/her.

4. The contract appointee will be entitled for one day's casual leave after putting one month's service, 10 days medical leave and 5 days special leave, in a calendar year. A female contract appointee with less than two surviving children may be granted maternity leave for 180 days.
