Subject: - Regarding withdrawal of Subsidy by the Govt. of Himachal Pradesh.

The Commission is in receipt of letter No. MPP-C(010)-5/2021-Part-II dated 31-12-2024 (Copy enclosed) vide which it has been communicated that the GoHP has decided that subsidy under Domestic Supply shall not be available for consumption of electricity w.e.f. 1.1.2025 for which bills are to be issued in February, 2025 for the following class of domestic consumers:-

(i) Group-A and Group-E employees/pensioners of Govt. of HP as classified vide Department of Personnel letter No. PER(AP)-C-A(3)- 5/2023-II (copy enclosed) dated 22.11.2022 (formerly categorized as Class-I and Class-II employees).

(ii) Group-A and Group-E employees/pensioners of the Central Govt. Boards, Corporation, Universities of State/Central Govt. Undertakings, State/Central Govt. PSUs employees working/residing in the State of Himachal Pradesh in corresponding pay scales/pay matrix as mentioned in the letter dated 22.11.2022.

(iii) This shall also be applicable to same class of employees/pensioners of Military and Para-Military Forces working/residing in the State of Himachal Pradesh.

The Commission, in its Tariff Order for the Himachal Pradesh State Electricity Board Limited issued on 15th March, 2024 in Petition Nos. 14/2024 and 15/2024, has determined the tariff for FY 2024-25 for various categories of the Consumers, after considering Subsidy to be provided by the Government of Himachal Pradesh (GoHP) at Table 293 and without Subsidy at Table 291.,

In view of above, I have been directed to convey you to take necessary action in the matter as per the Tariff Order dated 15.03.2024.

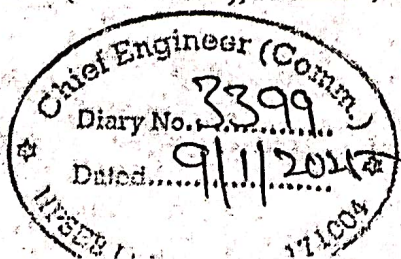
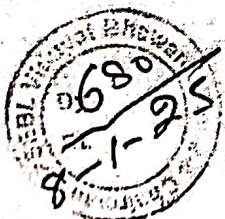
