NOTIFICATION

Consequent upon the approval of the Board of Directors of the Corporation in its 173rd meeting held on 07.10.2023 vide Item No. 173.9, point no.1 (**OBJECTIVE**), point no. 4 (**SIZE OF PANEL**) and point no. 7 (**SELECTION PROCEDURE**) of the Notification No. HPSCSC/Admn.12-1/2015-IV-373-382 dated 17.04.2020 are hereby amended/re-notified as under:-

Point No. 1: OBJECTIVE:-

H. P. State Civil Supplies Corporation Limited has 40 Medicine Shops at various public health facilities and further propose to open Medicine Shops at 13 new places throughout the State as per public demand.

- I. The main objective of Corporation is to provide medicines and surgical items at best quality to the general public at reasonable rates.
- II. To provide medicines to the public round the clock within the Hospital Premises enabling easy availability of medicines.

Point No. 4: SIZE OF PANEL:-

Panel to be drawn shall be double the size of existing/anticipated vacancies. Presently there are 2 clear-cut vacancies and 11 shops are proposed to be opened in near future. Therefore, 13 Pharmacists are likely to be selected on commission basis for running these Medicine Shops of the Corporation. The panel to be drawn shall be double the size of existing vacancies i.e. 26, one each against the existing vacancies and one each against the vacancies arising due to the resignation or termination of agreement of existing Pharmacists (Commission Basis) or future vacancies, likely to arise etc., in the order of merit. The validity of panel so drawn shall remain valid for two years.


Point No. 7: SELECTION PROCEDURE FOR EMPANELMENT OF PHARMACISTS (COMMISSION BASIS).

Total 60 marks fixed for selection procedure for the empanelment of Pharmacists will be allotted in the following manner:-

Marks will be allotted on pro rata basis on percentage of marks secured in r/o a to c above. In r/o c above, the percentage of marks whichever is higher among Diploma or Degree shall be taken into consideration.
