It may be noted that vide Order No. HPSCSC/Admin-8288-8291 dated 04.10.2025 issued by the Managing Director, H.P. State Civil Supplies Corporation Ltd., certain revisions were directed to be made in the seniority lists of Clerks/Junior Assistants and Cleaners as on 31.12.2023 and 31.12.2024, as such, the seniority lists of the said cadres as on 31.12.2023 and 31.12.2024 were revised vide this office order dated 08.10.2025. However, the execution of the said order dated 04.10.2025 has been stayed by the Hon'ble High Court of Himachal Pradesh vide order passed in CWP No. 17873 of 2025 (CMP No. 27528 of 2025) titled Yash Pal v/s State of H.P. & Ors., which is pending adjudication. Therefore, the above seniority lists issued on 08.10.2025 were also stayed. Accordingly, the present seniority list is being issued as it is, subject to the final outcome of the said writ petition before the Hon'ble High Court of Himachal Pradesh.
